## 1. MAPPING YOUR VISIT OF OUR WEBSITE

### A. COOKIES

- i. A cookie is a small text file that is stored by the browser of your computer, tablet or smartphone when you first visit this website.
- ii. Barcol Air BV uses different types of cookies:
  - a. Functional cookies: These are cookies with a purely technical functionality. These ensure that the website works properly, so that it can, for example, remember your preferred settings. Using these, we can also optimize our website and the services through our website.
  - b. Analytic cookies by third parties: These cookies can keep track of your online behaviour. These cookies are used by Google Analytics.
  - c. Tracking cookies: These cookies are placed by an external party. By reading these cookies the advertiser recognizes you when you visit a site in which he is also involved. If you continue browsing, personalized ads can be shown. These cookies can also keep track of your online behaviour, which may result in a very specific profile being built by these parties. This profile can be so detailed that it is considered personal data.

### B. CHANGE COOKIE SETTINGS

- i. Your cookie settings were set by you on your first visit to our website. All non-functional cookies can be denied per category. Placement of cookies, other than functional or anonymous analytical cookies, takes place only after an active action by you as a visitor. You can change your settings at any time via our website

### C. LEGAL BASIS OF DATA PROCESSING

- i. Functional cookies: The basis for processing functional cookies is the legitimate interest of Barcol Air BV. The interest of Barcol Air BV is based on the need to ensure proper functioning of the website. However, the user's interest in maintaining his or her privacy is not exceeded, as functional cookies do not collect personal data that can be used for marketing or other purposes.
- ii. Analytical and tracking cookies: The basis for processing analytical and tracking cookies concerns the consent given to Barcol Air BV}. This article provides that the processing of personal data is only allowed if the data subject has given his or her unambiguous consent. The requested consent gives you, the user, control over your personal data and provides transparency on how this data is used.

## **2. COOKIE OVERVIEW**

### **A. COOKIE NAME, COOKIE TYPE, COOKIE FUNCTION AND THE RETENTION PERIOD**

### **3. GOOGLE ANALYTICS**

#### **A. GOOGLE**

- i. A cookie from Google is set via our website. These cookies are part of Google Analytics. We use this service to examine how you, as a visitor, use our website and Google produces insightful reports on this for us.
- ii. Google may provide this information to third parties if Google is legally obliged to do so, or if third parties process the information on behalf of Google. Barcol Air BV has no influence on this.

#### **B. PRIVACY SETTINGS**

- i. Through this cookie statement, we inform you about the use of Google Analytics.
- ii. Barcol Air BV has entered into a processing agreement with Google;
- iii. Google Signals is used. This feature gives us greater insight into the behaviour of our visitors on different devices;
- iv. Data collected is linked to other Google services;
- v. Your IP address is anonymised so that your location is not traceable.

### **4. NEW DEVELOPMENTS AND UNFORESEEN COOKIES**

- i. Our website can be modified at any time due to continuous developments. This also applies to our cookie statement. It is advisable to regularly review the cookie statement to stay informed of any changes.
- ii. On the website, use can be made of content that is hosted on other sites and that is accessible on our website by means of a certain code (embedded content). Think for example of YouTube videos. These codes often use cookies. However, we have no control over what these parties do with their cookies.

### **5. DELETE COOKIES?**

- i. You must delete your cookies yourself, if you wish. To do this, go to your internet browser, for example Google Chrome, Internet Explorer or Safari. You can also set your internet browser to notify you when a website uses cookies. You then decide every time whether you want to give permission for this. If you want to know more about this, you can use the help function of your browser.

It is not possible for Barcol Air BV to guarantee that these third parties handle your personal data in a reliable and secure manner.
